There appear on this contract:

Of the first part,

Mr. Sahil Mahajan, respectively President of United Punjab Football Club, for and on behalf of the said United Punjab Football Club, having its address at Village Kaunterpur, Jalandhar Pathankot Highway, Teh and Distt Pathankot 145101, and registered as a Member Club with the Punjab Football Association, ALL INDIA FOOTBALL FEDERATION, hereinafter referred to as 'the Club';

And of the second part;

Master _____, a academy trainee football player, bearing Indian Adhaar number _____, having his residence at _____, hereinafter referred to as 'the player'.

And by virtue of this contract, the parties are hereby agreeing the following:

1. **Term and Termination**

- 1.1 This contract shall be valid for One [1] football seasons and shall come into effect on [_____] and terminate naturally on the [_____].
- 1.2 The club can terminate this contract by giving one month prior notice.

2. **Remuneration & Bonuses**

- 2.1 In remuneration for his services the Club will not pay any money to the player as the player is trainee in the academy of the club. The club may divide the winning amount (from any tournament) among the winning squad or age group

3. **Obligations of the Player**

- 3.1 The player shall report for training and for football matches whenever requested to do so by the Club, and shall carry out his duties as a football player in other facility indicated by the Club.
- 3.2 The player is directly accountable to his Coach, and shall accept all decisions taken by the Coach with utmost respect and maturity.
- 3.3 The player shall obey all instructions given to him by the Club in relation to vacations, injuries, diagnostics, treatments and rehabilitation procedures.
- 3.4 In matches, training sessions and other club functions the player is to wear the appropriate attire or kit according to the guidelines of the team and club management.
- 3.5 Unless given consent by the club the player is not permitted to participate in matches other than those arranged by the club

5. It is agreed that the club is not liable in the event of death of the player and Major Injuries costing Rs. 3000/- or above in one season.

6. The Club shall be fully responsible for the diagnostics and full treatment of all minor injuries sustained by the player during providing football services to the Club

7. The player shall not absent himself from carrying out his duties without the express consent of the Club.

No amendment or alterations to the terms and conditions of the Agreement shall be valid unless mutually agreed in writing and signed by both the Club and the player.
